- 1.2 The Organiser reserves the right, at its sole discretion and without prior notice, to amend the Terms and Conditions at any time, including but not limited to changes in the event schedule, entry criteria, prize details, or cancellation of the event. Participation in the event constitutes acceptance of these Terms and Conditions, including any future revisions.
- 1.3 The Organiser's decisions on all matters related to the Event—including eligibility, participation, and the distribution of gifts and prizes—are final, binding, and not subject to appeal or correspondence.

2. Event Registration
