A: Schedule to Conditions of Entry

3. <u>Event timing and Venue</u>	<p>The Event will be held on 12th July 2025 from 9:00 AM to 9:00 PM (MYT). <i>Note: Registration closes at 8:30pm.</i></p> <p>Event Venue: Slate at The Row KL 50, Jalan Doraisamy, Chow Kit, 50300 Kuala Lumpur, Wilayah Persekutuan Kuala Lumpur.</p>
4. <u>Eligibility:</u>	The Event is open to all individual legal residents of Malaysia aged 18 years old (from the date of the Event) and above.

Participants are required to get or complete all the stamps from each booth in order to collect the door gift. - Any property damage caused by cats.
- Any physical or emotional distress suffered by cats or their owners due to environmental factors, crowd conditions, or other circumstances beyond the Organiser’s control.

Health and Safety Requirements:

- Participants must ensure their cats are in good health, fully vaccinated, and free from fleas, ticks, and contagious conditions.
- The Organiser reserves the right to refuse entry or remove any cat deemed unfit for participation due to health, safety, or hygiene concerns.

Conditions of Entry

1. Introduction

1.1 These Conditions of Entry are to be read in conjunction with the Schedule to Conditions of Entry. In the event of any inconsistency between these Conditions of Entry and the Schedule, the provisions of the Schedule shall prevail. Together, these documents constitute the "Terms and Conditions" governing participation in “Culinary Experience” event.

1.2 The Organiser reserves the right, at its sole discretion and without prior notice, to amend the Terms and Conditions at any time, including but not limited to changes in the event schedule, entry criteria, prize details, or cancellation of the event. Participation in the event constitutes acceptance of these Terms and Conditions, including any future revisions.

1.3 The Organiser’s decisions on all matters related to the Event—including eligibility, participation, and the distribution of gifts and prizes—are final, binding, and not subject to appeal or correspondence.

2. Event Registration

2.1 By attending Fancy Feast “The Culinary Experience” event participants confirm that they have read, understood, and agree to be bound by the Terms and Conditions.

2.2 All costs and expenses associated with attendance at the Event—including but not limited to transportation, cat supplies, and personal expenses—shall be borne solely by the participant.

3. Eligibility

3.1 The Event is open to all individual legal residents of Malaysia aged 18 years and above. The Organiser reserves the right to request proof of eligibility, including identification documents, as a condition of participation.

3.2 Employees of the Organiser and its affiliated companies, and immediate family members of such employees, are not eligible to register for the Event.

4. Disqualification

4.1 The Organiser reserves the right to disqualify any participant who:

- 4.1.1 Provides inaccurate, incomplete, or misleading registration details;
- 4.1.2 Violates any part of the Terms and Conditions;
- 4.1.3 Behaves in a manner deemed unsafe, disruptive, or inappropriate at the Event.

4.2 In cases where a disqualification occurs after the issuance of gifts or prizes, the Organiser reserves the right to revoke or reclaim such items.

5. Gifts & Prizes

- 5.1 Gifts and prizes are awarded strictly at the Organiser's discretion and are subject to availability. They are non-transferable, non-exchangeable, and not redeemable for cash.

6.3 The Organiser is not liable for:

- 6.3.1 Injuries caused by one cat to another;
- 6.3.2 Property damage caused by cats;
- 6.3.3 Emotional or physical distress suffered by cats or owners.

6.4 The Organiser reserves the right to deny entry or remove any cat that poses a health or safety risk, at its sole discretion.

7. Publicity

7.1 The Organiser may use a Participant's entry including without limitation, photos, drawings, text, and any other content or information submitted for purposes of the Event (collectively the "Materials"), and the Participant's name, and/or likeness, for advertising, publicity and Event of any goods or services of the Organiser, for an unlimited time throughout the world without compensation, and in any media. The Participant shall do all things necessary to give effect to this if requested by the Organiser.

8. Intellectual Property Rights

8.1 The Participant agrees that all intellectual property rights in any contents and/or materials submitted, made or created by the Participant in connection with the Event and any derivative works arising there from will perpetually and unconditionally be vested in, assigned to and owned by the Organiser. The Organiser has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

9. Indemnity

9.1 Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Nestlé Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Event, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Event or violation of the Terms and Conditions,

10. Limitation of Liability

10.1 The Organiser, Purina PetCare (Malaysia) Sdn. continuation in force of the remainder of the Terms and Conditions of the Event.

11.5 Where the Terms and Conditions of the Event is prepared in English and any other language(s) in the event of any inconsistency between the English language and the other language(s), the English language version shall prevail and govern in all respects.

11.5 The Terms and Conditions of the Event shall be construed, governed and interpreted in accordance with the laws of Malaysia.
